Scrutinizer's Report

Sir,

I was appointed as a Scrutinizer by the Board of Directors of Mahindra CIE Automotive Limited ("the Company"), at its meeting held on Monday, 25 April, 2022 for scrutinizing the votes cast by Postal Ballot which was carried out by electronic means through the remote e-voting facility only ("Postal Ballot"), on the items of business set out in the Notice of Postal Ballot dated Monday, 25 April, 2022. I submit my report on the result of Postal Ballot as under:

- 1. The Company completed the e-mail dispatch of Notice of Postal Ballot on Monday, 23 May, 2022. The Notice was sent to the Members whose names appeared in the Register of Members / List of Beneficial Owners as received from National Securities Depositories Limited and Central Depository Services (India) Limited as on Friday, 20 May, 2022.
- 2. The voting rights of members were considered in proportion to the paid-up value of their shares in the equity capital of the Company as on Friday, 20 May, 2022, the "cut-off date" fixed by the Company.
- 3. The Notice of Postal Ballot was sent to the e-mail IDs of Members, which were registered with their Depository Participants (in the cases of dematerialized shareholding) and with the Company's Registrar and Transfer Agent (in the cases of physical shareholding).
- 4. No printed copy of notice of Postal Ballot and Postal Ballot Form were sent to the Members and they were required to communicate their assent or dissent through remote e-voting facility only.
- 5. The e-voting module of KFin Technologies Limited was enabled on Wednesday, 25 May, 2022 at 9.00 A.M. and disabled on Thursday, 23 June, 2022 at 5.00 P.M. During this period, Members of the Company, holding shares in physical and dematerialized form, as on the cut-off date, were able to cast their vote through remote e-voting on the resolutions set out in the Notice of Postal Ballot.
